Notice is hereby given that the Hon'ble National Company Law Tribunal, Hyderabad has ordered the commencement of corporate insolvency resolution process against Mack Soft Tech Private Limited on August 11, 2017 vide its order dated August 11, 2017.

The financial creditors shall submit their proof of claims by electronic means only. The operational creditors, including workmen(s) and employee(s), may submit their proof of claims in person, by post or electronic means. The moratorium for prohibiting, *inter alia*, all types of suits, recovery & actions against said corporate debtor under section 14 of the IBC is ordered with effect from August 11, 2017 till completion of the corporate insolvency process or until the Bench approves the resolution plan under sub-section (1) of Section 31 or passes an order for liquidation of corporate debtor under section 33, whichever is earlier.

Submission of false or misleading proofs of claim shall attract penalties.
